The quiz is not a pass-fail exam; however, participants will receive a one point demerit for each incorrect answer.

Completed Driver Packet due March 2, 2011

NOTE: Forklift operators must be deemed competent by their employer to operate a forklift safely. The employer's proof of operator training/evaluation should be a photocopy of the employer's documentation showing the operator was trained and evaluated to operate the forklift safely. Per OR-OSHA Div 2/N 29 CFR 1910.178(I)(6): "The employer shall certify that each operator has been trained and evaluated as required by this paragraph (I). The certification shall include the name of the operator, the date of the training, the date of the evaluation, and the identity of the person(s) performing the training or evaluation."
